

It is hereby notified for information of all concerned that, in order to ensure transparency and accountability, the Board will continue the system of Re-evaluation of Answer Scripts of the SSLC/HSSLC Examinations. A photocopy of the Answer Script(s) will be given on request along with a prescribed fee. In the light of this provision, the following points may kindly be noted for information and necessary action.

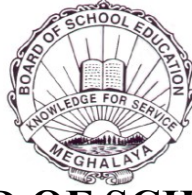
1. A period of 5 (five) days after the declaration of results will be given to candidates to apply for a photocopy and Re-evaluation of Answer Script(s). On the expiry of this period, applications shall not be entertained.
2. An application for Re-evaluation will be entertained only after the candidate has first obtained the photocopy of the Answer Script(s). On application, a photocopy of the Answer Script(s) with marks will be provided and thereafter a window period of 2 (two) days will be given to apply for Re-evaluation, if so desired. However, while giving the photocopy of the Answer Script(s), names of the Head Examiner, Examiner and Scrutiniser which appear on the scripts will be concealed.
3. A candidate who desires to get a photocopy of the Answer Script(s) shall have to sign an undertaking with a pledge to maintain utmost confidentiality. Under no circumstances will the candidate reveal the photocopy to the press or take any action with malafide intentions of maligning the Board. Any violation of the undertaking will render the result of the candidate null and void and the examination of the candidate will be liable for cancellation.

The rates for obtaining a photocopy and for Re-evaluation are as follows:

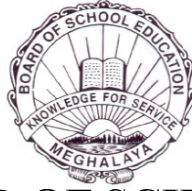
